Regardless of the reason, cancellations result in additional costs and processing time for the retreat organizers, as such all cancellations are subject to at least a \$50 cancellation fee.

If the participant leaves the retreat for any reason prior to its conclusion, refunds will not be made for the unused portion of the retreat.

No refunds will be made for any excursion, meal, etc...or other activity that the participant misses or decides not to participate in for any reason.

The retreat is subject to a minimum enrollment of 10 participants and a maximum of 14 participants. The retreat organizers reserve the right to cancel the retreat prior to departure. If such a cancellation is NOT due to circumstances beyond the retreat organizers control, such as war etc, as set forth below, the retreat organizer will refund all payments, constituting full settlement with the participant. No compensation will be made when cancellation arises before or during the trip from circumstances beyond our control (force majeure) such as, COVID-19 upsurge, war, strife, civil disobedience, strikes, terrorist activity, adverse weather conditions, fire, natural disasters, etc., unless or until the retreat organizer is able to recover any retreat related sums. In the event of cancellation arising from circumstances beyond our control, as set forth above, retreat related sums recovered by the retreat organizer will be distributed equitably to the participants after the retreat organizer deducts all out of pocket costs and related expenses.

It is required that participants purchase their own trip insurance. ## **NATURE OF THE RETREAT**

This is a yoga retreat for anyone age 18 and older. Accordingly, participants are encouraged to fully attend all of the offerings provided. All participants are encouraged to approach the Retreat with a spirit of openness, oneness, adventure and self-discovery.

Smoking is NOT permitted in vans, cars, at meals, or inside buildings or yoga or sacred spaces.

## **PASSPORT AND VISA**

A passport must be obtained in advance. Each participant is responsible for determining their specific passport requirements and for obtaining the necessary documents prior to departure. If you already have a passport, double

check the expiration date and be sure it is not set to expire within six months of the departure date. If so, renew it prior to the departure date.

A Tourist Visa **is not** required for Portugal.

## **MEDICAL INSURANCE**

For your own safety, well being and financial protection, it is essential that you are adequately insured. Each participant is responsible for checking with their current health insurance provider and ensuring that they have adequate medical coverage. Participants must carry insurance documentation while on the retreat.

## **MEDICAL PROBLEMS/DISABILITIES**

If you have a medical condition or disability which may affect your participation, you must inform us before confirming your booking so that we can advise as to the suitability of the chosen retreat. You must also provide us with full details in writing at the time of booking, and notify us of any changes or deterioration in the disability or medical condition or development of any disability or medical condition after booking.

We reserve the right to decline any booking or cancel (in the event of the development, deterioration or change of any disability or medical condition occurring after confirmation) whenever we reasonably feel unable to accommodate the needs of any particular participant or we feel that the participant could be in danger.
